
MFFTING CALENDAR:

3rd Tuesday morning of each month – 8 Pacific, 9 Mountain, 10 Central Time

MEMBERSHIP STATUS:

Ester Mae and Nileen organized all dues information available. The chart at right shows the month of last dues payment for members of the ToP Network.

The chart below summarizes the dues status. It





was recommended that the 4 members who paid dues on September 28, 2011 be considered current for 2012, bringing currently paid member count to 75.

Expediting a membership renewal campaign is priority. If we can get these 60 members to renew, membership will be at 135 – 15 short of the 2012 goal!

MEMBERSHIP POLICY:

Nancy shared sample policies prior to the meeting. From these a framework was proposed to target our initial focus specifically on issues relevant to membership renewal. (See Attachment A.) Agreeing that this was a useful start, the committee discussed several policy issues.

Discussion included:

- Questioned the possibility of half year dues. For those interested in joining later in the year, this could be appealing. Would these be available to anyone or just for new members?
- Focus on keeping things simple so they can be managed.
- Might membership year be October 1 September 30 to better line up with annual conference promotion and fee collection?

- How could we use timing to encourage signing up for the conference?
- Might we have a grace period that allowed members who had not renewed to still access the member rate for the conference? How would we manage this? Could tracking via excel spread sheet suffice?

Recommendations included:

- Dues received in the quarter prior to the membership year are applied to the membership year.
- Membership year is Oct 1 Sept 30.
- We begin with a single class of membership individual. Discuss the possibility of organizational membership in a future meeting.
- Members who have not renewed by April 30, 2012 to be dropped from Groupsite.

Nancy will take the lead on drafting a policy framework with initial elements we are ready to propose. We will refine these elements via email communication. Nancy is to have a first draft by March 5.

Table for further policy discussion:

- Roles who makes decisions?
- Do we need/have verification they have taken the course?
- Is there a Network sponsor?
- Are new member decisions Membership Committee responsibility? Or done by the Board?

RENEWAL CAMPAIGN:

Renewal outreach needs to occur ASAP. Ester Mae recommended Attachment B as a good list of benefits for use in renewal outreach. A draft of the communication to go out to past due members will be included in a report to leadership for their March 12 meeting. Ester Mae will work on the draft with the goal to have a first draft by Monday, March 5.

NEW MEMBER CAMPAIGN:

Where are the next 100 new members? Sherwood will take the lead in drafting ideas for the new member campaign for the March meeting agenda. Ideas surfaced during this meeting included:

- Ask members to help recruit new members
- Develop an attractive, professional brochure that would be included in every TFM and TSP manual.


USE OF WEBSITE FOR MEMBERSHIP PURPOSES:

The fulfillment project Suzanne is leading is focused on assisting with course enrollment, not membership. We should pursue this idea further. Nileen will take the lead on this as well as a first stab at an associated budget for this


